Brother Sir Knights:

As the Lenten Season is upon us, we are reminded of the ultimate sacrifice our Lord made for us. We are also reminded why we are

Knights to serve and sacrifice for our fellow man. During Lent our Council 10514 Brothers will serve a Fish Fry Dinner to the SMdM parish community on each Friday evening after Stations of the Cross. I ask our Sir Knights to come forward to help Council 10514 with this effort each Friday during Lent. This is a sacrifice that we should be willing to endure for our Savior as a remembrance of his suffering. We were advised that on Good Friday there will not be a Lenten Fish Fry.

* The Four Chaplains' Medal was a decoration approved by an Act of Congress on July 14, 1960 (P.L. 86-656, 74 Stat. 521). The decoration recognizes the heroic actions of four Army Chaplains during World War II in recognition of the extraordinary heroism displayed by them. They sacrificed their lives during the sinking of the troop transport Dorchester in the North Atlantic in 1943 by giving up their life preservers to other men aboard the ship.
