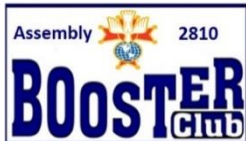
## BOOSTER CLUB

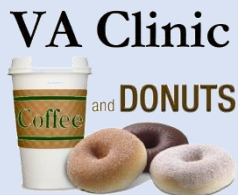

## Bishop Felipe J. Estévez Ordains Six New Priests

Deacons Maurice Culver, Jared De Leo, Anthony Hamaty, Chris Knight, Clay Ludwig, & Mason Wiggins were ordained to the priesthood on June 20th at the Cathedral Basilica of St. Augustine. This was the largest group of seminarians to be ordained

in our diocese in decades! Bishop Estévez stated, "Through the Rite of Ordination and through the power of the Holy Spirit, these brothers will be set apart for priestly ministry."



***Fr. Anthony Hamaty is a member of Corpus Christi Assembly 2810. His first parish assignment will be at Queen of Peace Parish in Gainesville.. Below is his BIO as published in the May/June 'St. Augustine Catholic':***

Anthony Hamaty grew up in Miami in a large Lebanese Catholic family, went to Catholic school, and then attended medical school at the University of Miami and spent his career in pediatrics.

"I enjoyed being a pediatrician, but something was missing. I started going on mission trips and thoroughly enjoyed them. I went to the Dominican Republic and went on pilgrimages to Lourdes and Rome.

In Lourdes, one day, Deacon Hamaty was helping in the men's bath, lowering people into the water. "One elderly man couldn't get his socks on, and so I was helping him, and at that moment, I flashed to the Lord washing the apostles' feet. That was a 'wow' moment, no subtleties."

He began praying and reflecting on his life and decided to pursue the priesthood, something he had first felt drawn to as a 12-year-old altar server at St. Brendan's Elementary in Miami. "I remember one day talking to a seminarian. Part of me aspired to be

in his shoes. He gave me his cross, and I still have it to this day," Deacon Hamaty said. "I remember the feeling of peace."

In college and medical school, he made an effort to go to the daily Mass at noon. "When I couldn't make it, the priest would say, 'Meet me on 4 West in the hospital.' We'd step into an empty room, and he'd give me the body of Christ. I felt rejuvenated. I don't think I would have become a doctor if it weren't for the Lord.

"Leaving my practice and patients was bittersweet. Some of my patients were bringing their children to me. But I really felt this was the direction I needed to go. Some people call us late vocations, which implies God's timing was off. I prefer 'seasoned vocation.' He lets life form us."

Deacon Hamaty said he knows the coronavirus is challenging the church he will serve as a priest. "I really feel for the people who can't receive the Eucharist," he said. "Christ is among the people, and they become our Eucharist. You see the best of people coming out. Its people helping each other. We see our oneness again. It's what the Lord puts in our hearts that helps us recognize him in the other."
