# Father Kazimierz Ligeza Installed as Pastor of Santa Maria del Mar

Bishop Felipe J. Estévez formally installed Father Kazimierz Ligeza as Pastor of Santa Maria del Mar in Flagler Beach on December 16, 2018. Approximately 200 parishioners, family and friends were present for the ceremony.

Father Kaz was born and raised in Poland and come from a very religious family. His father was an organist for many years in his home parish and his mother was a teacher at a local school as well as being actively involved in many ministries in their home parish. Fr. Kaz has four brothers and two sisters. One of his brothers, Fr. Jan, is also a priest and currently the pastor of St. Paul's in Jacksonville, FL. Father has a passion for singing and plays the organ, piano, and guitar.

After graduating from high school, Fr. Kaz entered the Seminary in Tarnow, Poland and

was ordained to the priesthood in 1990. He obtained a Masters in Theology and continued his studies at the Pontifical University in Krakow, Poland receiving his License in Social Teaching of the Church and was awarded a Doctorate in Homiletics. Before coming to the

United States, Fr. Kaz served as parochial vicar, pastor, and teacher of religion in several parishes. Fr. Kaz came to the United States in 2003 to study English and Spanish. Upon completion of these studies, he was assigned to Queen of Peace Parish (Gainesville FL) in 2005 and served as Parochial Vicar until June 2018 at which time he was appointed as Pastor of Santa Maria del Mar.

Father Kaz serves as Chaplain for Notre Dame Council 10514. He is also a 4th Degree member of Corpus Christi Assembly 2810.














